Online CE Course

Care at the Crossroads » HOW CRISIS RESHAPES THE FUTURE OF HEALTH AND HEALTH CARE

COURSE DESCRIPTION

Times of crisis often trigger an avalanche of emergency measures ostensibly designed to help healthcare systems adapt to novel conditions. History teaches us, however, that changes implemented during a disaster often become the norm after the crisis has subsided. Whether pertaining to the hospital industry or to community health more generally, the long-term implementation of emergency measures can have devastating consequences for patients, as well as interfere with nurses' ability to provide safe and effective care.

This class will examine the crisis measures currently being implemented during the COVID-19 pandemic. We will look at changes both to the health care industry and to policies affecting the structural and environmental conditions that impact community health. We will examine what potential longterm consequences such changes could have for patient care, and crucially — discuss how nurses can identify such measures and fight back against their permanent implementation.
